Minutes of the Ordinary Meeting of Constantine Parish Council held on Thursday February 21, 2013 at 7.00pm in The Vestry, Constantine.

The Chairman welcomed members and visitors to the February meeting.

# **PUBLIC QUESTION TIME**

Members noted that

- the Diamond Jubilee Steering Group has decided to keep to its original plan to site the previously chosen granite boulder in The Square for which it must needs continue to seek funding
- residents of properties fronting the modified Public Right of Way at Seworgan have expressed concern that their rights of access may have been compromised. This is not so, there is no change in the right of vehicular access to their properties as a result of the Modification Order
- a large and dangerous pot-hole has developed in the road just beyond the entrance to Bosvathick riding stables. The Clerk agreed to report this
- the road down to Merthen Manor has been resurfaced.

Cllr Gray (illness), Cllr Nicholls (holiday) and PCSO Gardiner sent their apologies for absence. Cllr Miss Evans proposed, Cllr Wiseman seconded all in favour to accept these apologies.

# 3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Mrs Dunstan proposed, Cllr Bolt seconded, all others in favour that the minutes of the Ordinary Meeting held on Thursday January 17, 2013 are a true record and the Chairman signed them as such.

# 4 MATTERS ARISING FROM THE MINUTES BUT NOT INCLUDED ON THIS AGENDA

There were no matters arising.

# 5 POLICE REPORT

Through the Clerk, PCSO Gardiner reported that there have been four crimes (thefts of a lawn mower and of an inflatable boat, failure to observe the terms of an injunction and the possession of cannabis) recorded in the Parish since the meeting in January. There were a further twenty-four calls concerning, variously, the use of drugs, disputes between neighbours, the welfare of individuals and a vehicle collision. There were two calls in relation to anti-social behaviour. The Police urge everyone to report any information they may have about illegal activities by telephoning the non-emergency number 101.

# 6 CORNWALL COUNCILLOR'S REPORT

CCllr Hatton reported that

- he is awaiting delivery of those materials necessary for the maintenance of the historic fingerposts in the parish
- Cornwall Highways has offered to supply road scalpings for the repair of Public Rights of Way
- construction of the solar farm at Little Trevease is well under way
- as reported in the local press, the Planning Authority has received a pre-planning application for six houses and associated workshops in Port Navas
- a recent meeting of the full Council agreed to set a county-wide housing target of 42,250 new homes to be built in the next twenty years: Falmouth sought and was given an increase of 1,100 homes in their allocation, a figure which will inevitably affect surrounding rural parishes. Following consultation, the revised figure will be referred back to the Secretary of State (who originally recommended a figure of 68,000 new homes) before being passed to the Planning Inspectorate for the necessary inquiry
- although the Cabinet has recommended an increase of just under 2% (to avoid the potential for a referendum) in the Council Tax, there is a move amongst Members to freeze it for a third year
- such a move may affect community grants which are presently administered by the Community Network.

In answer to a question concerning the structural changes in the Planning Department and present-day Planning Officers' apparent lack both of expertise and in-depth knowledge of the area, CCllr Hatton stated that Officers are frequently based some considerably distance from application sites (making site visits unusual), that objections to applications have to be based firmly on planning reasons and that Parish Councils should continue to express their views forcibly.

# 7 PARISH COUNCIL MATTERS

# **Constantine Lawn Cemetery**

Drawing members' attention to the document written by Cllr Bolt, Cllr Gray and himself concerning proposed improvements both to the area in the Lawn Cemetery set aside for cremated remains (the *Garden of Remembrance*) and to the access paths, Cllr Wiseman stated that the Parish Council had made no capital improvements to the cemetery since its initial purchase and landscaping in 2002/2003. It was their opinion that the cost (including all labour) of erecting a post and chain fence to enclose the *Garden of Remembrance*, of renovating the raised garden bed and wooden seat, of purchasing a bronze plaque to identify the area and of repairing the access paths throughout the cemetery should be no more than £2,500. Speaking on behalf of members, the Chairman thanked Cllrs Bolt, Gray and Wiseman for the work they had all done towards moving this project forward. Cllr Mrs Dunstan proposed, Cllr Mrs Scott seconded all in favour that Constantine Parish Council should immediately put all the improvements described above into action.

# 8 PLANNING APPLICATIONS AND DECISIONS

# **Applications**PA12/11689 Mr M.Bruton – Demolition of boathouse and erection of a dwelling – land adjoining

Bosoljack, Quay Road, Port Navas. Cllr Wiseman proposed, Cllr Bolt seconded all others in favour that this application should be returned with the following observation Constantine Parish Council considers that the size and scale of the proposed dwelling on this prominent site is such that it will have an adverse and detrimental effect on the look of the settlement and the surrounding area. Moreover, the development is unsustainable in terms of the National Planning Policy Framework. The existing settlement, which is without any services, is incapable of supporting additional housing. If permitted, it will create further vehicular movements on the already crowded narrow roads which serve the settlement. Constantine Parish Council requests the Planning Authority to refuse permission for development.

PA13/00348 Mr David Aitken – To remove 2 UPVC windows and replace with 2 UPVC French Doors – The Old Chapel, Seworgan Cllr Lewis proposed, Cllr Mrs D'Alton seconded all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

PA13/00489 Mr H.Garbutt – Demolition of existing garage and the construction of a 1 bed annex – 17, Parc Monga. Cllr Wiseman proposed, Cllr Bolt seconded all others in favour that this application should be returned with the following observation *Constantine Parish Council can confirm the applicant's statement concerning his daughter's need for this annex and supports the application.* 

PA13/00546 Mr and Mrs Daly – Formation of ancillary room within roof space above existing detached garage – 10 Brillwater Road. Cllr Mrs D'Alton proposed, Cllr Bolt seconded all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

PA13/00796 Mr T.Denny – Erection of new dwelling – land adjacent to Trewince House, Port Navas. Cllr Bolt proposed, Cllr Mrs Scott seconded all others in favour that this application should be returned with the following observation Constantine Parish Council believes this application to be for a new home in the countryside (and indeed within the Cornwall AONB). Certainly it represents a further intrusion of the built environment into the natural environment – on which it will have an adverse effect. Moreover, the development is unsustainable in terms of the National Planning Policy Framework. The existing settlement, which is without any services, is incapable of supporting more housing. If permitted, it will create further vehicular movements on the already crowded narrow roads which serve the settlement. Constantine Parish Council requests the Planning Authority to refuse permission for development.

PA13/01189 Mr M Rowe – Conservation Area Consent for the demolition of dwelling – 36 Fore Street, Constantine. Cllr Mrs Dunstan proposed, Cllr Wiseman seconded all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

His wife being the applicant, Cllr Carter declared a pecuniary interest in the following application. He relinquished the Chair and left the room. Cllr Wiseman assumed the Chair.

PA13/00375 Mrs Christine Carter – Removal of agricultural occupancy condition relating to Decision Notice dated 30th November 1985 – Trengilly Vean, Bridge. Cllr Mrs Dunstan proposed, Cllr Bolt seconded all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

Cllr Carter returned to the room. Cllr Wiseman relinquished the Chair which was assumed by Cllr Carter.

#### 10 FINANCIAL MATTERS

# 11 REPORTS FROM COMMITTEES AND REPRESENTATIVES

Cllr Miss Evans reported that she had attended a Neighbourhood Planning Landscape Assessment training session at the end of January. The proposed methodology had proved to be a cut and paste exercise using the recently published Management Plan for the Cornwall AONB as a base document. The resultant document would form an important part of a Neighbourhood Plan, an introduction to which may be found on the Cornwall Council website.

# 12 COMMENTS FROM COUNCILLORS

Members expressed concern about the widespread incidence of inconsiderate parking and blatant disregard for the rules of the Highway Code evident throughout the village and particularly outside the school. Following extensive discussion, the Clerk was asked to write to the Headmistress and to the Chair of the Parent Teacher Association with a request that parents' attention be drawn to the problems created by such thoughtless and selfish behaviour.

In the light of Cornwall Highways' observations on the proposed entrance to the car-park at Potager Garden (PA12/11192) members repeated their fears that, should the development proceed, lives will be at risk.

Speaking of Robert Williams' move to Gloucestershire to be nearer his family, the Chairman said that his presence on the Council will be sorely missed. He has served the community well for many years, initially as a member of Kerrier District Councillor and more recently as a Parish Councillor. His enthusiasm coupled with his knowledge and experience of local government had combined to make him a valued member of Constantine Parish Council. He wished Robert and his wife, Sally, a long and happy retirement.
