1 ELECTION OF CHAIRMAN

6 MATTERS ARISING AND NOT COVERED ELSEWHERE ON THIS AGENDA

Cllr Bolt reported that the gentleman who had made the now defunct notice-board for Seworgan had stated that he would be unable to make a new one.

Cllr Wiseman reported that he was no further forward with a light for Clinton Road, but that he had painted the step so that it is now more visible.

7 CORNWALL COUNCILLOR'S COMMENTS

CCllr Hatton reported that

- using some of his allocation of the funding available under the Community Grant scheme, he may be able to help pay for a new community notice-board at Seworgan
- a consultation document concerning the allocation scheme for affordable housing in Cornwall (Cornwall Homechoice) is available on-line

Chairman's initials.....

- Cornwall's community building grant scheme aimed at introducing 'green' measures has come to an end: Community Energy Plus (a charity with expertise in sustainable energy) can give advice
- a recent meeting of the Community Network Panel had focussed on rural public transport and an assurance had been given by an officer from Cornwall that the local route (number 35) would continue to attract subsidy. Those present had noted the success of Falmouth's shuttle service (which is undertaken by Constantine's O.T.S. Minibus and Coach Hire company)
- there are calls for a relief road to be constructed at Perranaworthal: regular flooding and subsequent closure of the A39 has strategic implications for a large portion of the west of Cornwall
- the next meeting of the Community Network Panel will be in September at Ponsanooth. There are calls for it to be open to members of the public.

8 POLICE REPORT

Through the Clerk, PCSO Bill Wood reported that there were 50 crimes recorded in the Parish in the year since the last Annual Meeting. Categorised, the crimes logged were 6 thefts, 2 burglaries, 3 criminal damage, 3 assaults, 2 drug-related, 5 harassment, 4 taking of a motor vehicle, 4 child protection incidents and 21 miscellaneous offences. Seven of these crimes have been detected. Although this represents an increase on last year's figure, as a whole crime in the force area is on the decrease and Cornwall remains one of the safest places to live in the country.

Again through the Clerk, PCSO Gardiner reported that three crimes have been recorded in the Parish since the meeting in April. There have been nine further calls relating to nuisance neighbours, missing people, domestic incidents, a road traffic collision and an abandoned 999 call.

The Recreation Ground

Cllr Nicholls reported that old railway sleepers have been laid in readiness for the hut to be erected; that a recommendation for the purchase of an outdoor table tennis table will be made by the JuMP advisory committee in the near future: that the play area has now been levelled and turfed; that the play equipment company (Proludic) intends to start installation work on Monday and that the plan is for the area to be officially opened during the carnival weekend in late June.
