Cllr Wiseman was asked a question concerning the number of times it is anticipated that a defibrillator will be used and further whether or not training in their use will be made available. He replied that he did not know how frequently any given defibrillator was used but that training would certainly be available once the defibrillators are in place.

5 POLICE REPORT

Through the Clerk, PCSO Fuller reported that a single crime (of criminal damage) and six incidents were reported to the police during the month of November. He reminds residents that, as Christmas approaches, it is wise to ensure that both homes and cars are secure to avoid opportunistic theft.

6 CORNWALL COUNCILLOR'S REPORT

CCllr Bastin reported that

- Cornwall Council's new Chief Executive Officer has been appointed: she is Kate Kannally who is currently the deputy CEO of Barnet in north London
- Falmouth's Neighbourhood Plan envisages blocks of flats rather than individual homes to deal with present and future pressures of housing
- the revised Cornwall Local Plan increases the target number of new dwellings in the Falmouth and Penryn Community Network Area by about 100
- there is some financial help available to those Councils currently providing public facilities (Constantine Parish Council provides public conveniences and play areas amongst others)

- the Boundary Commission review (which seeks to provide equal electoral representation) has been brought forward to April 2016 and will report before the Cornwall Council elections in May 2017. The probable outcome will be that the number of Cornwall Councillors will be reduced by up to a third. Cornwall Council has written to the Boundary Commission expressing its alarm about the proposed earlier review
- talks about the future of the Post Office in Constantine are on-going.

Following extensive discussion, Cllr Nicholls proposed, Cllr Andrew seconded all in favour that quotations should be sought to refurbish the existing shelter – and that such refurbishment should be left until the weather is more clement.

Applications

PA15/10558 – Change of use of part of owners/staff accommodation to letting rooms – Trengilly Wartha Inn, Nancenoy. Cllr Wiseman proposed, Cllr Mrs Dunstan seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

PA15/10641 Mr D.Martin – Retrospective permission for an extension to form bedroom – Trebarvah Farm, Constantine. . Cllr Andrew proposed, Cllr Mrs Dunstan seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

PA15/10964 Mrs Judy Ford – Notification of proposed works to trees in a conservation area. Coppicing of one multi-stemmed ash and one elm – The Old Doctors House, Doctors Lane, Constantine. Cllr Mrs Thomson proposed, Cllr Bolt seconded, all others in favour that this application should be returned with the following observation *Subject to the approval of the County Tree Officer, Constantine Parish Council supports this application*.

PA15/10900 Miss Serena Kent – Erection of a single storey local needs dwelling – Trewarne, High Cross. Cllr Nicholls proposed, Cllr Andrew seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

PA15/11003 Mr D.Martin – Variation of Condition 2 (plans approved) of decision PA14/06663 (erection of 8 dwellings, 1 shared ownership dwelling and 3 open market dwellings) to allow minor material amendment for rotation of plot 5 plan through 90 degrees – Plot 5, Trebarvah Court, Constantine. Cllr Bolt proposed, Cllr Andrew seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council*

is aware that the developer has already completed the proposed development and that the proposed 'variation' is now a matter of fact. The application should have been for retrospective approval. The record shows that Constantine Parish Council made the following observations about the original application

"Constantine Parish Council views this application as one for eight new homes in the countryside. Eight new homes which will have a considerable visual and ecological impact on the character and appearance of the countryside surrounding the village. There are already concerns about vehicular traffic (particularly along the very narrow lane from Trebarvah Road through to Trewardreva Cross) which will be augmented by the adjoining development. Constantine Parish Council does not support the development of this exception site and requests the Planning Authority to refuse permission for development."

The decision to grant permission for the original application was made despite the Parish Council's valid and reasoned objections and contrary to the emerging Cornwall Local Plan, which requires support from the local community for the development of an exception site.

Constantine Parish Council does not consider the rotation of a dwelling through 90 degrees to be a minor material amendment. Moreover (and particularly on summer evenings) such rotation will take light from and spoil the reasonable enjoyment of the occupants of plot 4.

In line with its stance on the original application, Constantine Parish Council requests the Planning Authority to refuse permission for the proposed variation.

PA15/11113 St Constantine PCC – Works to trees – St Constantine's Church, Church Square. Cllr Wiseman proposed, Cllr A.Carter seconded, all others in favour that this application should be returned with the following observation Subject to the approval of the County Tree Officer, Constantine Parish Council supports this application.

PA15/11337 Mr L.Gilewicz – Extension to dwelling – Hendrawna House, Polwheveral. Cllr Mrs Dunstan proposed, Cllr Bolt seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

Decisions

PA15/06302 APPROVED – Works to oak. (Reduce height by 5 metres to a height of 25 metres. A 3 metre reduction on the branches reaching towards the house, the branches around the sides will be matched in so that they are shaped in with the branches reaching away from the house. The branch length on Tree 2 before reduction is approximately 10 metres. The branch length following reduction will be approximately 7 metres. Remove two crossing branches at approximately 10 metres) – Trevean, Trewince Lane, Port Navas – noted

PA15/08836 APPROVED – Bedroom extension to ground floor, new utility extension to first floor and garage conversion. Refurbishment of roof, exterior walls and installation of new double glazed windows – Cove Hill, Port Navas – *noted*
