Minutes of the Ordinary Meeting of Constantine Parish Council held on Thursday April 21, 2016 at 7.00pm in The Vestry, Constantine.

The Chairman welcomed members and visitors to the April meeting.

#### **PUBLIC OUESTION TIME**

Seeking the Council's support for his planning application (PA1900949), Mr H.Dickinson explained his personal circumstances and outlined his proposals for this local needs dwelling. He was supported by Mrs Trickey.

Mr Jorey stated that, together with members of the Football Club, he is prepared to do the work necessary to refurbish the pavilion. He asked if the Parish Council would be prepared to underwrite the costs involved. The Chairman suggested that he should make a list of what needs to be done together with an estimate of the costs involved and come back to the Council. The Council would then consider the matter further.

# Members noted that

- an arm of the historic fingerpost at the corner of Trebarvah Road (near the school) has again been broken off. The Chairman undertook to arrange for its repair
- the lower two hinges of the doors of the bier house need replacement. Cllr Andrew agreed to investigate further
- BT is preventing residents from signing up to fibre broadband. The Clerk will pursue the matter
- the build-out at the northern end of Brillwater Road (which was a condition of the permission for the development of the Nans Avallon site) has yet to be constructed.

#### St Constantine Closed Churchyard

Members considered an offer to extend the contract with Cornwall Council for cutting the grass in the closed churchyard of St Constantine for a further year at the same annual rate of £433.01 Cllr Andrew proposed, Cllr Mrs Dunstan seconded all others in favour to continue with the contract to maintain the closed churchyard at St Constantine.

# 9 PLANNING MATTERS

#### **Observations**

PA16/00949 Mr H.Dickinson – Outline planning permission with all matters reserved: Proposed construction of a single infill dwelling (amended application) – land adj The Old Smithy, Jobs Water. Cllr Wiseman proposed, Cllr Andrew seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council supports the amended application for a Local Needs dwelling*.

PA16/02483 Mr and Mrs Thomas – Raised ridge to incorporate bedrooms and shower room within the loft space, with 2 no. pitched roof dormers and 2 Juliet balconies to the rear – Pinfold, Bowling Green Cllr Mrs Thomson proposed, Cllr Wiseman seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council supports this application*.

PA16/02538 Mrs A.Meadows – Tree works as per application documents – Poltoge, Port Navas. Cllr A.Carter proposed, Cllr Andrew seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council will be guided by the views of the County Tree Officer*.

PA16/02672 Mr J.Watt – Works to Beech tree – The Old Orchard, Port Navas. Cllr Andrew proposed, Cllr Mrs Thomson seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council will be guided by the views of the County Tree Officer*.

PA16/02728 Mr and Mrs L.Gilewicz – Erection of garages and garden store – Hendrawna House Polwheveral. Cllr Mrs Dunstan proposed, Cllr Wiseman seconded, Cllr Mrs Thomson abstained all others in favour that this application should be returned with the following observation Constantine Parish Council notes that the size, height, footprint and design of the proposed outbuilding are all markedly similar to those of the earlier refused application (PA15/01666) for the erection of a treble garage, gardener's store with a residential annexe over. Constantine Parish Council further notes that the Planning Inspector appointed to decide that application referred to its height and size, stating that it would be far more dominant than the existing building" and "would not be perceived as [a] minor component of the wider landscape". In her conclusions, the Inspector found that "notwithstanding that the proposal replaces an existing structure, it would be significantly higher, larger in terms of massing and more prominent. It would be an incongruously large new domestic building in this rural landscape setting, seen in association with two already large dwellings. Further planting would not be sufficient to overcome its harmful impact on the character and appearance of this highly attractive and essentially natural rural landscape." Constantine Parish Council believes that the Inspector's comments concerning the earlier proposal and the structural similarities between that and the current application militate against permission being granted and therefore requests the Planning Authority to refuse permission for development.

PA16/02773 Mr C.Mitchell – Application for a non-material amendment following grant of planning permission PA15/00627. Amendment sought - widen proposed door to bedroom 3 (extension) in south elevation – Golden Eye, Port Navas. Members noted that, due to time constrictions, the Chairman had authorised the return of this application with the following observation *Constantine Parish Council has no further comment*.

PA16/02902 Mr L.Mann – Siting of a static caravan for residential use and use as a farm office. Retrospective. Resubmission of PA15/00820 – Meyn Pern Farm Office Caravan, Tresahor. Cllr Andrew proposed, Cllr Mrs Dunstan seconded, all others in favour that this application should be returned with the following observation Constantine Parish Council reiterates its objection to the original application PA15/00820 which was 'Constantine Parish Council notes the absence from this application of any justification for a new residential unit within an unsustainable location in the countryside and accordingly requests the Planning Authority to refuse permission for development.'

PA16/03102 Mrs J.Ford – Notification of proposed works to trees in a conservation area. Branch and epicormic growth removal and canopy raising of sweet chestnut to 6 metres. Felling of flowering cherry – The Old Doctors House, Doctors Lane, Constantine. Cllr Miss Evans proposed, Cllr A.Carter seconded, all others in favour that this application should be returned with the following observation *Constantine Parish Council will be guided by the views of the County Tree Officer*.

#### 12 REPORTS FROM COMMITTEES AND REPRESENTATIVES

Cllr Mrs Thomson reported that she and Cllr Andrew had attended the recent Community Network Meeting. Amongst other matters, the following were of note

- grants are available from the devolution fund for costs associated with setting up the various duties devolved from Cornwall Council (libraries, public conveniences etc) and for day-to-day running costs in the first year
- much of the 2% levy on the Council Tax designed to ease the integration of Health and Social Care will in fact be spent on implementing costs associated with the new living wage
- the creation of Neighbourhood Plans was highly recommended by CCllr Andrew Wallis
- the forthcoming Boundary Review, the findings of which will be implemented in 2021
