1 ELECTION OF CHAIRMAN

Cllr Nicholls proposed, Cllr Wiseman seconded, all others in favour that Cllr Paul Carter be elected to the Chair of Constantine Parish Council for the year 2016 – 2017.

2 CHAIRMAN'S DECLARATION OF ACCEPTANCE OF OFFICE

Cllr Carter read aloud, signed and dated the statutory Declaration of Acceptance of the Office of Chairman of Constantine Parish Council for the year 2016 - 2017 in the presence of the Clerk and the Council.

3 APOLOGIES FOR ABSENCE

Apologies for absence were received from Cllr Bolt: Cllr Wiseman proposed, Cllr Andrew seconded, all others in favour that Cllr Bolt's apologies should be accepted.

4 DECLARATIONS OF INTEREST

Cllr Carter and Cllr Andrew both declared a pecuniary interest in Agenda Item 13 (a request from the Constantine Agricultural Association for help with funding).

5 CONFIRMATION OF MINUTES OF PREVIOUS MEETING

Cllr Andrew proposed, Cllr Mrs Thomson seconded, Cllr Nicholls who was absent from the last meeting abstained, all others in favour that the minutes of the meeting held on Thursday April 21, 2016 are a true record and the Chairman signed them as such.

6 MATTERS ARISING AND NOT COVERED ELSEWHERE ON THIS AGENDA

The Chairman referred to the question of the proposed refurbishment of the pavilion which was raised by the Football Club at the last meeting of the Council. Following wide-ranging discussion (during the course of which it was noted that members of the Football Club are willing to undertake the necessary work if the Parish Council will pay for the cost of materials and that the guttering, the doors, the windows, the paint-work and the changing-room all need repair or replacement), it was agreed that Cllr Andrew will make a costed list of the materials necessary for these repairs. The repairs will be the subject of an agenda item at the meeting in June to which Mr Brian Jorey will be invited.

7 CORNWALL COUNCILLOR'S COMMENTS

CCllr Bastin reported that,

- Cornwall Council has held its Annual Meeting and that nothing much has changed: John Pollard remains the leader and Ann Kerridge remains the Chairman
- in four years' time Cornwall Council will be required to be self-sufficient there will be no Central Government funding. The bulk of its income will come from business and domestic rates

- the new Chief Executive, Kate Kennally, has committed Cornwall Council both to greater transparency and to proper, consequential dialogue with Town and Parish Councils
- a Traffic Restriction Order will be considered as a way of dealing with the school run traffic
- Cornwall Councillors have agreed a pay rise of 14.6% for those Councillors who will be elected in May 2017
- the next meeting of the Community Network will be on May 26 when the main topic of debate will be the allocation of devolution funding.

In answer to a question, CCllr Bastin confirmed that the developer of the fifteen new homes at Trebarvah Farm will not be compelled to pay the typical education contribution for this size of development, neither will he be compelled to pay the full amount of the Open Spaces contribution of £12,006 (as calculated and required by Cornwall's adopted Open Space Strategy). After protracted negotiation and evidently with considerable reluctance, the developer agreed to pay a reduced sum of £5,000 as his Open Space Contribution. This is due to be paid prior to completion and before occupation of the fifteenth dwelling and not (again as is required by Cornwall's Open Space Strategy), prior to occupation of 50% of all dwellings. Councillors noted that the Planning Authority would appear to be somewhat inconsistent in its interpretation of Cornwall Council's adopted protocol.

8 POLICE REPORT

There was no report from the Police. However, Cllr Wiseman reported that he had received a telephone call from the Police in relation to the Neighbourhood Watch Scheme.

Cllr Wiseman proposed, Cllr Mrs Dunstan seconded, all others in favour that Cllr Nicholls be elected to the position of Vice-Chairman of Constantine Parish Council for the year 2016 – 2017.

Cllr Mrs Thomson proposed, Cllr Wiseman seconded all others in favour that Constantine Parish Council should re-adopt Standing Orders as revised in October 2014.

Financial Regulations

Cllr Mrs Thomson proposed, Cllr Wiseman seconded all others in favour that Constantine Parish Council should re-adopt Financial Regulations as revised in October 2014

Risk Assessment document

Cllr Mrs Thomson proposed, Cllr Wiseman seconded all others in favour that Constantine Parish Council should re-adopt the Risk Assessment document as revised in March 2015
