Minutes of the Ordinary Meeting of Constantine Parish Council held on Thursday October 20, 2016 at 7.00pm in The Vestry, Constantine.

The Chairman welcomed members and visitors to the October meeting.

PUBLIC QUESTION TIME

Mrs Parnell expressed concerns about the number of mature trees that have recently been felled, particularly to the west of the village. Members agreed with this sentiment feeling that their removal detracts from the landscape character of the village. It was noted that Cornwall Council has insisted that trees overhanging the road are trimmed or removed to allow the passage of double-decker buses.

4 MATTERS ARISING FROM THE MINUTES BUT NOT INCLUDED ON THIS AGENDA

There were no matters arising from the minutes which are not included on this agenda.

5 CORNWALL COUNCILLOR'S REPORT

CCllr Bastin reported that

- the Local Plan is scheduled to be signed off at a full meeting of Cornwall Council on November 22 although county-wide housing allocations are still out for public consultation
- the Unitary Authority has signed up to pilot the retention of Business Rates: this does mean that grants from Central Government will not be forthcoming and the position regarding small business rate relief is unclear
- on November 4 at the Methodist Chapel in Falmouth a presentation 'Thinking Differently' will examine how Cornwall Council will look in ten years' time. One suggestion is that the present Cabinet should act much as Cornwall County Council did in the past and that the Community Network Areas with their elected Councillors should act as the District Councils used to do
- Public Rights of Way enforcement issues have been taken back in house by Cornwall Council. The new Head of Enforcement is Gavin Smith.

6 PARISH MATTERS

Alice Hext Trust: repair of the pavilion

Members noted that no further work on the pavilion has been undertaken by the Football Club.

The Alice Hext Trust: replacement of a section of the chain-link fencing

Members noted the lack of any progress on the replacement of the chain-link fencing between the Social Club and the pavilion. Mr Atkinson had been instructed to undertake the repair in November 2015 and that instruction was restated in April 2016. In the circumstances it was agreed that the Council acting as the Management Trustee should seek quotations from other suitably qualified fencing contractors.

Welcoming Stones

The Chairman suggested that he and two or three other Councillors should meet at the quarry and pick out three blocks of granite for engraving. The Clerk was asked to seek advice from Wearne's as to the size necessary for the chosen form of words.

The new car-park

Members considered a proposal to add a tarmac strip to the car-park both to prevent stone being washed down the road and into the drains and to act as a footpath. Following discussion, during the course of which it was noted that quotations for the work had been obtained from D.A.Giles and from Cormac, the Chairman proposed, Cllr Wiseman seconded, all others in favour that Cormac (which originally constructed the car-park) should be instructed to carry out the work, but that the Clerk should do his best to negotiate a better price.
