## Alice Hext Trust: Cornish hedge fronting Trebarvah Road

Members noted that the play equipment needs some specialised maintenance and agreed that the matter should be discussed at the meeting in January.

Members noted that the Highways and Environment Manager has agreed that the Welcome to Constantine stone on the Gweek Road can be sited on the now very over-grown verge just before the entrance to Brillwater Road, thereby making a delineation between Bridge and Constantine. The Chairman reported that he would arrange for those interested to visit the quarry in the New Year.
