### 8 POLICE REPORT

Speaking before the meeting proper had begun, PCSO Fuller detailed the crimes that had been reported over the past six months within the local policing area for Penryn and the outlying villages. He described the Parish of Constantine as being 'very quiet'.

Members noted that a Sycamore tree in the Recreation Ground may be causing damage to a neighbour's house. The Chairman will take a look at it and, if he feels it necessary, will give instructions for it to be cut down. The Cherry tree on the path between Penbothidno and Bowling Green also needs some pruning, but it was agreed to do this in the autumn.

The Chairman proposed, Cllr Andrew seconded, all others in favour that Mr Peter Richards (formerly Kerrier District Council's Chief Auditor) should be re-appointed as Constantine Parish Council's Internal Auditor for the year to March 31, 2018.

## The co-option of Parish Councillors

The Clerk reported that the Council has a duty to co-opt three Councillors on to the Council. It was agreed to advertise the vacancies on the notice-boards.

#### **General Power of Competence**

Cllr Bolt proposed, Cllr Mrs Thomson seconded, all others in favour that Constantine Parish Council, having met the conditions required under The Parish Councils (General Power of Competence) (Prescribed Conditions) Order 2012, should re-adopt the Power of Competence.

## 10 PARISH MATTERS

#### **Alice Hext Recreation Ground**

Members considered an offer from the Social Club to lease the Pavilion from the Alice Hext Trust and therefore to take on its repair and day-to-day maintenance and, possibly, its long-term future. During the course of discussion, it was noted that, under the terms of the Alice Hext bequest, the grounds of the Recreation Field cannot form part of a lease to a third party because they are open at all times to residents of Constantine (which means that, in the event of a lease being granted, the Pavilion building alone would become the responsibility of the Social Club). With this in mind, it was agreed that the Parish Council acting as the Management Trustee would consider leasing the Pavilion to the Social Club for an initial period of two years and that the situation would be reviewed at the end of those two years.

# Sports/Fun afternoon

Members considered a request for the Recreation Ground to be used for a Sports/Fun afternoon on August 20, 2017. Following discussion and acting in its role as the Management Trustee of the Alice Hext Recreation Ground, the Council agreed to grant permission for Ms Pearce to hold a Sports/Fun afternoon on the Recreation Ground on August 20th, 2017 on condition that the event is free of charge and open to all.

## **Welcoming Stones**

The Chairman reported that Chris Wearne had made the suggestion that the wording might be engraved on a piece of slate which would then be inset into the stone. Following a very short discussion, it was agreed that that proposal is not in line with the heritage of the parish and that the words should be engraved into the stone itself as originally envisaged.

It has no objections in principle to the addition of a conservatory to this dwelling. However the Council has strong reservations about the proposed design* 

PA17/01311 Dr and Mrs Aghdam – Listed Building Consent for proposed interior remodelling of converted barn, demolition of rear extension and erection of conservatory – Ponjeravah House Ponjeravah. Cllr Mrs Dunstan proposed, Cllr A.Carter seconded all in favour to return this application marked *Constantine Parish Council has no objections*.

PA17/03290 Mr & Mrs Papastavros – Outline planning permission with some matters reserved: Demolition of existing buildings and construction of a dwelling – land south of Panoramic View, Tucoyse Lane, Higher Brill. Cllr Bolt proposed, Cllr Andrew seconded all in favour to return this application marked *Constantine Parish Council views this application as being for a new home in the countryside in an unsustainable location where the vehicular access is poor and would therefore request the Planning Authority to refuse permission for development.* 

PA17/03744 Mr & Mrs Harris – Replacement of existing conservatory/ kitchen extension with new enlarged extension – The Reens, Brillwater. Cllr A.Carter proposed, Cllr Wiseman seconded all in favour to return this application marked *Constantine Parish Council supports this application*.

PA17/04083 Hadlands – Works to a tree subject to a tree preservation order. Felling of one Western Red Cedar – Ponjeravah House, Constantine. Cllr Bolt proposed, Cllr Wiseman seconded all in favour to return this application marked *Subject to the agreement of the County Tree Officer, Constantine Parish Council supports this application*.

PA17/04096 Mr J.Phipps – Change of use only: existing summerhouse used at present for hobbies and arts/crafts to be converted into a Dog grooming salon for commercial use – 22 Trebarvah Road, Constantine. Cllr Andrew proposed, Cllr Mrs Thomson seconded all in favour to return this application marked *Constantine Parish Council supports this application*.
