The Chairman welcomed members and visitors to the September meeting.

PUBLIC QUESTION TIME

Members noted that

- there are again concerns about the puddle which, at times, extends across most of the road outside Bosvathick. Members suggested that what is needed is for the hole through the hedge to be faced with stone and for a ditch or a French drain to be constructed in the field to allow the water to drain away gradually. CCllr Bastin undertook to report this matter to Cornwall Highways
- the recycling bins in the car-park need re-labelling so that there are two bins for glass and three for plastic and metal; additionally the paper/cardboard bin needs to be bigger. In the light of recent collection problems experienced by Biffa, it was agreed that a notice should be put on the wall requesting motorists not to park in the entrance on whichever day Biffa is due to collect. The Clerk will take this matter forward.

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Wiseman proposed, Cllr Mrs Dunstan seconded, all others in favour that the minutes of the Meeting held on Thursday July 20, 2017 should be adopted as a true record and the Chairman signed them as such.

4 MATTERS ARISING FROM THE MINUTES BUT NOT INCLUDED ON THIS AGENDA

No matters arising from the minutes which were not included on this agenda were raised.

5 CORNWALL COUNCILLOR'S REPORT

CCllr Bastin reported that

- there was little to report, so little indeed that the first full meeting of the Unitary Authority is scheduled for November
- in an effort to increase the rate of re-cycling a proposal has been made at County Hall to collect recyclates every week and to collect household waste once a fortnight. Member were very much against this proposal stating that households, currently recycling as much as they can, cannot recycle more; that households

which do not recycle materials are unlikely to be encouraged to do so as a result of this measure and that to reduce the collection of household waste to once a fortnight will increase the incidence of fly-tipping and that there will inevitably be consequential problems relating to health, vermin and disease

- the link bus, which currently takes some twenty-five students from Constantine and Mawnan, to catch the bus to Truro College had been cancelled but, at his insistence, has since been reinstated, though only for the current academic year
- Neighbourhood Plans are currently being developed in both Mawnan and Budock – and the process itself had been the subject of discussion at the recent Community Network Meeting. CCllr Bastin stated firmly that such Plans afford Parishes some measure of control over planning matters, but admitted that that the Planning Authority has the final say. Both Cllr Mrs Thompson and Cllr Andrew, who had attended the Community Network Meeting, were of the opinion that the creation of Neighbourhood Plans requires a great deal of work and that the result of that work is heavily influenced by the Planning Authority. Members felt strongly that the democratic process appears to be absent from matters relating to planning
- in answer to a question deploring the Unitary Authority's decision to cut entirely the grant of £20,000 to Cornwall's Young Farmers' Club, CCllr Bastin agreed that rural communities appear to be bearing the greater burden of cost-cutting measures. It was noted that the Young Farmers' Club has been responsible for the development of many young men and women whose number includes the Leader of Cornwall Council, CCllr Adam Paynter (and whose debating skills were honed in the Club).

6 PARISH COUNCIL MATTERS

Co-opted members

The Clerk reported that he had received no expressions of interest in standing for co-option as a Parish Councillor.

7 PARISH MATTERS

Alice Hext Trust: repair of the pavilion

Members noted that a letter detailing those matters that the Parish Council (acting as the Managing Trustee of the Alice Hext Trust) require to be added to any future lease of the Pavilion had been sent to the Social Club Committee; and that the Committee had suggested that representatives from either side should sit down and talk through those details. An answer stating that the lease of the pavilion to the Social Club is dependent on the inclusion of those details has not, as yet, received a reply.

The Clerk was asked to write to the Club stating that the lease does need to be brought up-to-date, regardless of whether or not the pavilion is to be included.

Welcoming Stones

The Chairman reported that the three boulders are now with Wearnes. Once they have been inscribed, Mr Wearne will install them and for that reason the Chairman proposed and it was agreed that the corner at the south-eastern end of Brillwater road should be cleared out in readiness. The Chairman undertook to speak to Robert Bowden about this.
