# 5 CORNWALL COUNCILLOR'S REPORT

CCllr Bastin reported that

- Cornwall Council's Boundary Review proposals now include the Parish of Gweek with those of Constantine, Mabe and Mawnan
- an open meeting of the Boundary Review Panel will be held on July 31 but, whatever recommendations are promulgated, it is the Electoral Commission which will make the final decisions
- applications for a share in the Community Network funding for street works should be forwarded as a matter of urgency. (Members noted that Constantine Parish Council has already sought funding for increased on-street parking outside the school)
- passengers may now take their dogs with them on the Truro Park and Ride services
- following recent events in other parishes, members noted that a licence to fell any tree which has a trunk greater than four inches in diameter must first be obtained from the Environment Agency.

#### 6 PARISH COUNCIL MATTERS

### **Financial Regulations**

Following the decision taken at the Annual Meeting, members reviewed Constantine Parish Council's Financial Regulations. Following discussion, Cllr Nicholls proposed, Cllr Andrew seconded and it was agreed to re-adopt Financial Regulations with alterations to *Paragraph 10.1 (a) Procedures as to contracts* such that it now reads

(a) Where it is intended to enter into a contract exceeding £5,000.00 in value for the supply of goods or materials or for the execution of works or specialist services other than as set out above the Clerk shall invite tenders from at least three firms.

# **Delegated Powers**

Members considered awarding delegated powers to the Chairman and the Clerk to deal with day-to-day matters relating to the Parish Council during the month of August 2018. Following discussion, Cllr Andrew proposed, Cllr Mrs Thomson seconded, all others in favour that the Chairman and the Clerk should have delegated powers to deal with day-to-day matters relating to the Parish Council during the month of August 2018.

#### The Alice Hext Trust

Members considered the following statement which, it has been advised, will satisfy the requirements of Charity Law in the matter of the new lease for the Social Club

The Parish Council (in exercise of its power as the Managing Trustee of the Alice Hext Trust) resolved, having considered the report of Edward Buckland (RICS Registered Valuer), that the terms of the proposed lease to the Trustees of the Constantine Social Club are the best that can reasonably be obtained for the Charity, the principal terms being as follows:-

- 1. An annual rent of 3.75% of the club's yearly turnover (based on income from all the Club's activities), or £3,750.00 per annum, whichever figure is the higher.
- 2. A review of the above rent (upwards only) every 3 years.
- 3. A term of 21 years.
- 4. The pavilion to be included in and to form part of the lease at an annual initial rent of £1 payable in advance.
- 5. Otherwise on the terms of the draft lease prepared by Messrs Hine Downing and submitted to the Clerk to the Parish Council for approval on February 15, 2018 subject to such amendments as have been recommended by the Parish Council's solicitor.

The Parish Council further resolved that Paul Charles Carter and Colin Frederic Pleydell Chapman are appointed to sign the Lease on behalf of the Alice Hext Trust.

Following discussion Cllr Mrs Dunstan proposed, Cllr Mrs Thomson seconded all others in favour that the above statement properly reflect the Parish Council's wishes.

# 7 PARISH MATTERS

# **Welcoming Stones**

The Chairman reported that he has had a meeting with Mr Robert Bowden with a view to clearing the two sites which need preliminary work (those at the at the south-eastern ends of Brillwater Road and of the village) and that, all being well, this will be done during the course of the current week. He has also spoken to Mr Chris Wearne who has undertaken to clean off the four stones, to deliver them and together with Mr Bowden help with their installation in early August.

#### **Public Conveniences**

Following an observation by a member of the public, members considered the decorative state of the public conveniences. It was agreed that the convenience would benefit from re-decoration and accordingly Cllr Andrew proposed, Cllr A.Carter seconded all others in favour to instruct Mr Viv Beckerleg to do the job as a matter of some urgency.

### **The Constantine Lights Committee**

Members considered a request from the Constantine Lights Committee for permission to plant one Christmas tree on the green next to the car park and another in the garden in The Square both in memory of Liz Moore. During the course of discussion, members noted that

- Christmas trees are not indigenous
- they grow quickly and, in time, tend to swamp they area in which they are planted
- the garden in The Square is gradually filling with the flowering shrubs planted there and
- existing overhead power lines will cause problems in the fullness of time

• two commemorative oak trees, which will eventually grow to a considerable height, have already been planted on the green. There is no room for a further large tree.

Members agreed that the sentiment behind the request is kind and fitting of the high regard in which Liz was held in the village and that she would have been touched by the thought that 'her' trees would have brought joy into the hearts of many at Christmas. Nevertheless, Councillors agreed that they could not accede to the Committee's request.

PA18/05642 Crownmark Developments Ltd – Proposed construction of single dwelling – Play Area, Comfort Wartha. The Clerk reported that he had sought further information from the Planning Officer concerning the legal implications of this application, the site of which is subject to an S52 agreement. She in turn had spoken to Cornwall Council's Legal Department and was now awaiting a reply. In the circumstances, members agreed that the Council's observation should be returned once the full facts are available.
