## The following matters should be noted

The following planning applications were considered and the appended observations were returned to the Planning Authority. Each observation was headed: The following observation is returned using delegated powers.

Chairman's initials.....

PA20/02580 Mr and Mrs Cooke – Proposed demolition of a house and annexe and construction of a replacement dwelling with variation of condition 2 in respect of decision PA19/10024 – The Oyster House, Port Navas Constantine Parish Council notes that the original application made particular reference to the fact that the replacement dwelling would be lower and therefore less intrusive within the rural landscape and moreover would not be seen from the river quite as easily as the existing dwelling. Having received permission for development, the Applicant now seeks to raise the roof line by over two feet (which somewhat contradicts his original argument in favour of a replacement dwelling). The Design and Access Statement makes reference to a 37% reduction in the volume of soil requiring excavation and 222 fewer lorry movements through the village: the completed application form (paragraph 5) makes reference to a 27% reduction in the volume of soil requiring excavation (stated as 339.42 cu metres) and 162 fewer lorry movements. Furthermore, the mathematics relating to both numbers of lorry movements through the village need checking. If a cubic metre of soil weighs 1.5 tonnes and a six wheeler lorry can carry 15 tonnes ...

Putting the above figures to one side, it is Constantine Parish Council's belief that the proposal to raise the roof-line will inevitably make the replacement dwelling more visible within the rural setting of this particularly tranquil corner of the Cornwall AONB and requests the Planning Authority to refuse permission for development.
