1 TO RECEIVE APOLOGIES FOR ABSENCE

CCllr Bastin, Cllr Jeffery (personal) and Cllr Mrs Scott (personal), sent their apologies for absence. Cllr Andrew proposed, Cllr Painter seconded and it was agreed to accept their apologies.

3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Painter proposed, Cllr Mrs Thomson seconded, Cllr Mrs Batley-Birch, Cllr Bolt, Cllr Nicholls and Cllr Wickins who were absent from the meeting in November abstained, all others in favour that the minutes of the meeting held on Thursday November 18, 2021 should be adopted as a true record and the Chairman signed them as such.

4 MATTERS ARISING FROM THE MINUTES BUT NOT INCLUDED ON THIS AGENDA

Speaking of the 20's Plenty initiative, Cllr Painter reported that, although he had found general support for the imposition of a 20mph limit on restricted roads, there are concerns about the halving of the existing 40mph limit which pertains throughout the North Helford zone and which would be viewed as a considerable inconvenience. The question had also been asked, once the 20mph limit is imposed will the speed humps all be removed?

5 CORNWALL COUNCILLOR'S REPORT

The Clerk reported that CCllr Bastin was unable to attend this evening's meeting, but wished everyone a very merry Christmas and a happy New Year.

6 PARISH COUNCIL MATTERS

PA/20/06881 Trebarvah Court

Members noted the decision made by the West Sub-Area Planning Committee on November 15, 2021 to approve permission for the development of 25 dwellings on an exception site adjoining Trebarvah Court to the north of the village. Constantine Parish Council believes that, on the day, members of the Committee may have been misinformed about two matters in particular. The first concerns the statement that the Cornwall Local Plan allows for an exception site to be added to an exception site (which is the case in this application). If this is the case, then it would appear logical that further exception sites may legitimately continue to be added one to another

until the county boundary is reached. The second concern is the statement that there are 49 individuals presently living within the Parish of Constantine, whose financial position enables them to be added to the Cornwall HomeChoice list and who each individually have need of a new dwelling. Whilst the Council understands that, under the terms of the GDPR, names and other details cannot be divulged, it questions whether or not the number could be justified were the application to be examined by either a Planning Inspector or a sitting Judge (who would both, of course, be able to check the legitimacy of the given figures).

Constantine Parish Council regrets the fact that the Planning Authority evidently views the rural village of Constantine as a dormitory, stating, as reported in the Committee's minutes, that "there is a range of services and facilities offered in the village" (despite the Parish Council's observations detailing the paucity of such services) and that "the local roads were challenging and narrow" despite the acknowledgment that "this development will increase traffic by a further 4%". Constantine Parish Council does not accept that the issues it has raised "have been addressed in the report"; rather it believes the issues it has raised have been swept under the carpet as being inconvenient. As an aside, the Council is surprised to note that with the one hand Coastline is selling property and with the other is seeking permission to build new. The Council hopes that the S106 legal agreement will require Coastline to offer properties to people on Cornwall's Homechoice list currently living in need in Constantine, rather than to people who have had their existing tenancies terminated simply because Coastline considers it expedient to sell the property.

7 PLANNING MATTERS

Planning Enforcement

Cllr Nicholls voiced the view held by the Parish Council concerning the absence of any meaningful planning enforcement action by the Planning Authority within the Parish. The Parish Council, he reminded members, spends a considerable amount of time deliberating properly-presented planning applications, but it is the case that particular individuals have simply taken the law into their own hands and done what whatever they please and, seemingly, without consequence. There are certainly four long-term outstanding issues if not more within the Parish which have all been properly reported to the Authority and recorded by it, but which date back a considerable length of time and which have not been resolved. The Planning Authority is clearly failing in its duty to protect the Parish of Constantine from unlawful development. The Clerk was asked to contact Mr George Eustice MP to ask him to raise the matter during the course of his monthly meeting with Cornwall Council and, further, to forward copies of that request to the Portfolio Holder. The plainly-evident inaction is bringing Cornwall Council into disrepute.
