## 3 CONFIRMATION OF THE MINUTES OF THE LAST MEETING

Cllr Bolt proposed, Cllr Andrew seconded, Cllr A.Carter, Cllr Jeffery and Cllr Wickins being absent from the last meeting abstained, and it was agreed that the minutes of the Ordinary Meeting held on Thursday November 16, 2023 are a true record and the Chairman signed them as such.

Cllr Wickins proposed, Cllr Mrs Deering seconded, and it was agreed that the minutes of the Parish Meeting held on Thursday November 23, 2023 are a true record and the Chairman signed them as being accurate.

#### 4 MATTERS ARISING FROM THE MINUTES BUT NOT INCLUDED ON THIS AGENDA

There were no matters arising from the minutes of the meeting held on November 16, 2023.

# 5 CORNWALL COUNCILLOR'S REPORT

CCllr Bastin reported that

- residents using the library will, in future, need a PIN to access on-line services
- Cornwall Council-owned street lighting will be switched off between midnight and five o'clock
- there are currently two hundred and twenty-six public charging points for electric vehicles in the county.

In answer to a question from Cllr Nicholls, CCllr Bastin undertook to jog Alan Mason's memory about coming to Constantine to answer questions concerning the apparent lack of action in progressing planning enforcement issues.

Speaking of the state of roads both in the parish and further afield, Cllr Wickins asked if something might be done particularly where blocked drains are concerned.

#### 6 PARISH COUNCIL MATTERS

#### Social Media

Following considerable discussion, Cllr Wickins proposed, Cllr Mrs Deering seconded and it was agreed to look into setting up an electronic notice-board, purely to make information more widely accessible. Members noted that this project will not be without cost. Cllr Mrs Deering undertook to make every effort to bring an example of what might be achieved to the meeting in January.

## 7 PARISH MATTERS

### **Christmas Lights Committee and Carnival Committee**

Members considered a request to make space available on the Recreation Ground for storage for both the Christmas Lights and the Carnival Committees. Cllr Nicholls proposed, Cllr Andrew seconded and it was agreed that if the old tractor shed is removed and a hard-standing created, two twenty foot storage containers might be sited there. The old Carnival Committee container will be removed.

#### The Gazebo

Following some discussion, Cllr Bolt proposed, Cllr A.Carter seconded and it was agreed to protect the ridges on the roof of the gazebo on the Recreation Ground with apex flashings.

# Maintenance of the village

Cllr Mrs Deering proposed inviting interested parties from the parish to an informal meeting at which differing ideas for the maintenance of public spaces might be expressed. Her intention is that those ideas would then be considered by the Parish Council at the February meeting, before contractors are instructed.

# The Green Space under the Trees - Welcoming notice

Having agreed to site a welcoming notice on the Green Space under the Trees, members further agreed the form of words to be used. Cllr Nicholls proposed and it was agreed to purchase and site a second new sign asking visitors to take their litter home.

## **Maintenance of the Historic Finger-Posts**

The refurbished finger-post from Brill is now ready to be reassembled and put back into position. Cllr Jeffery undertook to do this at the earliest possible moment ... and once the Christmas tree has been removed!

## **Public Rights of Way**

Members agreed to extend an invitation to Cllr Paul Simmons to address the Council at the meeting in January on the subject of managing maintenance of Public Rights of Way.

## 8 PLANNING APPLICATIONS AND DECISIONS

#### **Applications**

PA23/04337 Mr and Mrs Morgan – Replace the existing conservatory with a new single storey glazed extension and a first floor rear extension. Conversion of the outbuilding store to a garden room and wet storage – The Grange, Treviades. Cllr Jeffery proposed, Cllr Andrew seconded, Cllr Bolt against and it was agreed to return the following observation *Constantine Parish Council supports this application*.

PA23/09867 Mr N.Gundry – Works to Trees covered by a Tree Preservation Order (TPO) - T1 Oak - Crown reduction, T2 Oak - Crown reshaping, T3 Turkey Oak - Crown lifting, T4 Oak - Crown lifting – Clear Creek, Trewince Lane, Port Navas. Cllr Bolt proposed, Cllr Wickins seconded and with two abstentions it was agreed to return the following observation *Subject to the agreement of the County Tree Officer, Constantine Parish Council supports this application*.
